2020 AGM OF THE MRA – Scheduled for Wednesday 29th March 2020 had to be cancelled due to the Covid Lockdown.

CHAIRMAN'S REPORT

The principal issues faced by the MRA during 2019/20 were the threat and subsequent closure of Dorset Road School and the ongoing planning matter of The Porcupine. Sadly, Dorset Road School has now been closed permanently by The Spring Partnership Trust resulting in the loss of a much loved and excellent school. The Porcupine planning application rumbles on and we now expect a decision at a LBB Development Control Committee on 20th October. This remains hugely opposed by the local community with objections submitted to LBB outweighing support by 10 to 1, with continuing concerns about road traffic volumes and safety.

Your Executive has continued to meet by virtual meetings and my thanks go to all the Executive for their continued support and contribution along with all our local Councillors.

TREASURER'S REPORT

Audited accounts to 31/3/20 show that this year's income (£2,172) mainly from subscriptions covers expenditure (£1,439). Given the current Covid situation our Fund position allows the Treasurer to recommend waiver of the subscriptions for the current year 2020/21. However the ongoing slight decline in membership prompts the Treasurer and Executive Committee to recommend an increase of subscription from £2.50 to £3 for 2021/22. The waiver and increase would normally be voted on at the AGM but as this cannot happen at the moment, we would be glad to hear the views of members. These views may be expressed in response to the e-mail from the membership secretary. As Members often find they don't have cash available, the use of an alternative payment method is also being investigated.

Rebecca Young (1955-2019)

It is with great sadness that we report the loss of Rebecca who has died of cancer at the age of 64 years. Rebecca lived in the centre of Mottingham for many years and brought up her family here.

She enjoyed a successful career in Children's Services, taking a leading role in the London Borough of Southwark. Rebecca was totally committed to the welfare and education of young people. Following her retirement, Rebecca became a familiar figure in the village walking her small dog Barney, several times each day; latterly at a pace respectful of Barney's age and ability. She was always friendly, caring and happy to help anyone.

Rebecca joined the MRA Executive in 2015. She made a valuable contribution to activities, in particular,

education debates. She was an effective Treasurer of the Mottingham Festive Lights Committee for a short period until her death. Many Mottingham Road residents may also remember her as a diligent collector of MRA subscriptions.

Everyone on the MRA Executive appreciated Rebecca's positive, can-do attitude and willingness to lend a hand. She is very much missed by us all.

Dorset Road School

Following permanent closure of the school, the site is inevitably deteriorating. It is understood that formal amalgamation of Dorset Rd pupils into Castlecombe is under consideration by the Regional Schools Commissioner and Head Teachers Board. The site will revert to Bromley Council who have indicated that the proceeds of any sale will most likely be passed to the Academy Trust although LBB will be free to use the site or the proceeds of sale as they please. Concern has been raised as to what might happen to the site and the MRA have requested that we have some input into any decisions.

Porcupine Update

The saga drags on into its 8th year. Currently vacant and boarded up behind hoardings along the frontage to Mottingham Road the Porcupine Inn closed in March 2013 and the site was acquired by Lidl for £1.1 m (plus vat), without being put on the open market. Since then, Lidl have been attempting to obtain planning permission to demolish the Porcupine and build one of their "shed" design supermarkets. Their first attempt was refused by Bromley Council on 20 February 2014, and Lidl's appeal was dismissed by the Government Planning Inspectorate on 16 December 2014. Lidl resubmitted plans, earlier this year, and Bromley's Development Control Committee were not satisfied in aspects regarding access to the site by Lidl's 40 tonne articulated vehicles. The DCC agreed that an independent report be commissioned to address this. Lidl are proposing that the footway outside the library opposite the Porcupine is reduced in size by the removal of a

large crescent shaped portion of the footway (possibly in breach of current Covid guidelines). The published Glanville Consultants report contains much information obtained from Lidl's own agents, thus invalidating its "independent" nature. In addition, Glanville (with the agreement of the Planning Department) conducted traffic surveys on Mottingham Road in the middle of the COVID19 lockdown, when there was hardly any traffic on the road!

There have been many comments lodged on the Bromley Planning website. Of those lodged since 1st August there have been 81 objections, with 9 expressions of support for Lidl's proposals. We hope that the Development Control Committee, which is due to consider the application on 20th October, will recognise this, and finally throw out Lidl's unpopular proposal. We have been advised that there is a purchaser waiting in the side-lines who wishes to develop the site for mixed housing, and possibly a micro pub (there is a local pub operator interested in managing this). Do look at the objections on the Bromley Council website, there are some well thought out objections there.

West Hallowes

Information obtained from Greenwich Council reveals that the cost of installation of the 20-mph speed restriction and humps in West Hallowes totalled some £45000 for 10 humps. Cllr Tester agrees that they seem to be proving totally ineffective and is trying to persuade RGB Council to revisit the issue. The West Park pavement now continues unchanged across the road junction at the south entrance to West Hallowes. We have expressed severe safety concerns for partially sighted pedestrians with no tactile surface to indicate the crossing. We have been informed by the traffic department that pedestrians have priority on the 'designated footway' at this junction according to rule 170 of the Highway code, but no officially prescribed signage exists for such a junction. Many satnav devices seem to prefer West Hallowes to West Park. Cllr Tester has observed the situation and agrees that the resolution has to be more than a few extra bollards.
