LETTER FROM THE PRESIDENT

I am afraid I have an apology to make.

In the last issue of the *Mottingham News* I included a letter in which I expressed my regret that the congregation of St Andrew's Church had not taken part in the Remembrance Service at the War Memorial on 12th November last year. My letter was prompted by a circular letter received by the Residents' Association stating that a full Remembrance Service would be held in St Andrew's Church on Armistice Sunday. In my capacity as President of the Residents' Association and as local representative of the Royal British Legion I was also approached by a number of members of churches of other denominations. They were very concerned that St Andrew's would not be taking part in the joint service at the War Memorial. We therefore placed posters in the local shops and offices and took other steps to let Mottingham residents know that the Remembrance Service at our War Memorial would be taking place as usual. As it turned out the service at the War Memorial was well supported, and, not having been advised otherwise, I assumed that all or most of those who attended were either from the Church of Our Lady Help of Christians or from the Methodist Church.

Following the distribution of the last issue of the *Mottingham News* I was taken aback when it was brought to my attention that a large number of those who had attended the service at the War Memorial, including the members of youth organisations, were from St Andrew's Church. I was even more disconcerted when I was advised that St Andrew's Church had been represented on The Churches Together in Mottingham, the group which had organised the Armistice Service.

I therefore apologise unreservedly to those members of the congregation of St Andrew's Church who attended the Remembrance Service at the War Memorial, and particularly to those who, as representatives of The Churches Together in Mottingham assisted in its organisation.

It is obvious there are very strong objections to the application by Kwik-Fit to trade at the Gilbert's (Honda) site by the war memorial roundabout. Your Association has objected to the proposal, but at the time of preparing this newsletter for printing Bromley Council's planning committee have not considered the application. We sincerely hope they will listen to residents' fears of serious damage to our environment, including trading hours, noise pollution and traffic problems, and refuse permission.

Residents have been concerned to see the damage to our War Memorial by an articulated lorry. Fortunately Bromley Council have been able to trace the owners, thanks to the foresight of a witness who noted the details of the vehicle, and councillor Dyer has assured me that the necessary repairs will be made as soon as the Council's estimate has received approval from the driver's insurance company.

FROM OUR COUNCILLORS

Councillor Dyer (Bromley) has apologised that he is currently fully committed with his Council duties and other work, and a letter from Councillor Yeldham is on the next page, but our requests to your Greenwich Councillors have been ignored.

RESIGNATION FROM BROMLEY COUNCIL

The following is an extract from a letter our Secretary has received from Councillor Yeldham:

"I am writing to let you know that for personal reasons I have resigned my seat on Bromley Council. . . . I have a demanding job working for the Greater London Assembly and I do not feel that I have the time to fulfil my obligations to my family, employer and to the people of Mottingham. I have therefore, very reluctantly, reached the conclusion that I should step down from the Council. . . . There is much more to be done in Mottingham. We need anti-crime initiatives spread across the ward. We need road safety measures and we need to resist further encroachment onto our green spaces. I only regret that I will not be around to meet these challenges."

POLICE-COMMUNITY CONSULTATIVE GROUP

The Bromley Police-Community Consultative Group is an organisation that allows the public and representatives from organisations such as the Mottingham Residents' Association to meet with local senior police officers and discuss aspects of policing. There are no restrictions on who can attend. The meetings give an opportunity for questions to be put to senior police officers or to bring to their attention matters that are of concern.

The organisation meets six times a year at various locations around Bromley Borough. All meetings commence at 7.45 pm and end around 9.00 pm, although this often becomes extended. The next two meetings will be:

- Mon. 12th Nov. at Malcolm Primary School, Malcolm Road, Penge.

As a member of this organisation I was invited to take part in an "insight patrol", which is an initiative to allow people to see how officers carry out their everyday duties. This is an abbreviated account of my experience one Friday morning in May. The police have requested me to stress this is a personal account, and all names have been removed.

INSIGHT PATROL: I reported to Bromley police station at 0700 hrs Friday morning and was greeted by the station inspector. He said the officer scheduled to take me was not available, but would I mind going out in one of the "immediate response vehicles" instead? The rest of the introduction became blurred as my mind raced with, "Would I mind racing the streets, lights blazing – jumping red lights – every boy's dream come true". As we pull away, with me in the back, the crew advise me that in the event of an incident the driver will be busy and the radioman will be preoccupied relaying information. The message was understood: "When a call comes in be quiet and keep out of the way".

We would be patrolling the Penge and Crystal Palace area. Calls are listed as Immediate or Timed Response, dependent on the type of call. The officers had been in the force eleven and fifteen years; each had taken driving courses and the driver one stage further with a one month advanced driver's course.

Message on the radio: "Suspect intruder on premises". The mood changes and a pair of professionals take over. With siren, and lights blazing, we're off. Cars in front pull over, others stop, some letting us pass and others blocking the road. The driver goes through gaps where, if I attempted it, there would be paint and

glass all over the place. A driver, seeing the road clearing, takes advantage and comes from a turning on the right, straight in front of us, oblivious to the siren and flashing lights. How do you not see or hear a police car? We arrive and the officers are in action. Anti-climax. The room has been used; extinguished night-lights around the room, a bottle and a full ash-tray. A considerate burglar? No, somebody using the room for the night, I suspect. The officers check the locks and pass on some advice about the window locks requiring maintenance. Not much point in locks if the screws holding them are loose!

The next call comes in: "A woman reports being threatened with a dustbin in private road behind shops". Again traffic makes things difficult for our fast response. 85% of calls must be attended within twelve minutes. A dislike of "Traffic Calming" takes a turn; is it necessary on main routes? We arrive in less than three minutes of the call. She has left. We find a private access road and a builder doing renovation work. The rubbish bin was a 4ft square trolley type on four wheels. The builder said he had moved it so that two vehicles could pass. I ponder, was this an emergency?

Another call. We are passing vehicles, lights and sirens going, when the "Cancel" call comes through. The driver slows. "I'm not going to endanger people for no reason", is his comment.

Another call, "Owner reports vandalism to his car". When we arrive we cannot locate the owner. A call to control for more details reveals he has left with his car.

Another call: "Intruder on premises". We arrive to find the owner's dog had run into the house and the monitoring service had called before the owner could stop it.

I think about the radio messages I had heard that morning. Some officers had attended real crimes and arrests had been made. In our case I felt a lot of people had been put at risk for possibly the wrong reasons.

Please do report crime. The police can only do something if they know about it. When you report a crime try and be clear whether you need an officer NOW – ie you suspect a criminal is on the premises and can be caught, or you need immediate assistance. But have a thought about the pot plant stolen last night; do you really need an officer there this minute?

It's easy to want a police officer for our own immediate needs, and complain when we don't see one. My feelings at this time are, if you want more officers, talk to your politicians as well as to the police. In an emergency call 999. For other matters use the numbers on the back of this newsletter.

WAYSIDE GRAVE

We are delighted to learn from Julia Rimmer, owner of the land at 1a, Beaconsfield Road, that Transco are sponsoring the clearance and refurbishing of this unique wayside grave in conjunction with Bromley Council, who are making metal railings, similar to the original ones, to enclose the site.

Thomas Chester Haworth is buried with his entire family in the grave, originally in a fine mausoleum built in 1875 in what was then a country lane. The ornate edifice was flattened by blast during the last war and now only two stone slabs remain. Wayside graves are very rare, particularly in the London area; in rural districts they usually record the burial of a highwayman or are the site of some ancient battle. Thomas Haworth was a 19th century surveyor who laid out Eltham's first public drainage system. He even published his own local newspaper, The Eltham Journal, and his shop still stands in Eltham (now a long-established Estate Agents).

The first burial there was one of Mr Haworth's sons in 1875. Subsequent interments were in 1876, two in 1883 and Thomas Chester himself in 1887 at the age of 72. He was joined in 1895 by his wife, who died from burns in a fire at her home at 20, Devonshire Road, Mottingham. Documents discovered by the Eltham Society seem to indicate the family were buried on their own freehold land due to a quarrel Thomas Haworth had with Eltham Parish Guardians over the sale of top-soil from Eltham Common.

Thomas Haworth left two relics in Eltham: one a tall monument at the top of the High Street which disappeared early in the 20th century when modern drainage methods no longer required a tall fumigating shaft, and the other an extraordinary drainhole cover. The latter was situated until 1970 in Court Yard, Eltham, and was only removed when the road was widened to take a bus lay-by outside Grove Market. The drain-cover has been located in a museum in Woolwich and negotiations are taking place to obtain permission for it to be placed at the wayside grave as soon as the renovation work has been completed.

Thanks to Julia Rimmer, Transco and Bromley Council we are sure this small but historical site will once again be a proud part of Mottingham's history.

A NOTE FROM THE LIBRARIAN

One of the nicest libraries in Bromley Library Services is, as a lot of you already know, on your doorstep. It was purpose built in 1968 on the site of the old Board school, which was built in 1877.

Since I took up my appointment as Assistant Supervisor in April last year my staff and I have worked very hard to put Mottingham on the map. We decided to pilot monthly coffee mornings, and they have been so successful we are about to hold our ninth – the last in the current season. The subjects covered have ranged from reminiscences of war-time romances to ideas for making greetings cards for Easter or Christmas. In September we had a coffee machine delivered which is invaluable at times like these. Come and try it!

In order to generate income we also sell greetings cards, reading glasses, postage stamps and stationery, as well as Library publications. On Tuesdays during term-time we have our Children's Day. Baby Bounce and Rhyme is from 10 to 10.30 am (the highlight of my week when I see the babies' smiles) and story-time for the pre-school children from 2.15 to 2.45 pm. The top class at Dorset Road Infants' school comes for a story on Friday afternoons during the Summer Term.

We do hope you will use you Library as much as you can. If you don't already, please come and find out what a vital, up-to-date, friendly place it is.

OFF-PEAK TRAINS – A Reminder

Off-peak trains to London leave Mottingham at 20 and 50 minutes past each hour for Charing Cross (stopping at Lewisham) and 11 and 41 minutes past each hour for Cannon Street (stopping at St Johns & New Cross).

You can go direct to Victoria by starting from Eltham Station. Alternatively you can travel from Mottingham and change at Lewisham, but isn't it about time we had some Victoria trains on our line too?

MOBILE THOUGHTS

We love our mobile telephones (said to be used by 40 million people) but where can we site the necessary masts and other equipment? The answer seems to be N-I-M-B-Y !

Two recent applications for installing masts in the Mottingham area, we understand, have been refused by Bromley planners, and one by Greenwich, for environmental reasons. BT Cellnet had plans for a 15m. high mast to be located in the garden centre in Mottingham Lane after Greenwich had rejected an application to place it on the corner of West Hallowes and the A20. Clearly this is a pleasant rural area of Mottingham and the applications were rightly considered to be of damage to the environment for local residents.

A third installation (by Orange) was for a 4m. high mast on the roof of the Kipling telephone exchange in Grove Park Road. This was refused as the effect would have been excessively obtrusive on a low rise building in pleasant residential roads.

Your Association objected to all these applications in letters to Bromley and Greenwich on health, as well as environmental, grounds. Many people have serious concerns about the effect of mobile phones on our health, particularly where young children are exposed to the radiation. It is generally recognised that scientific research on the effect of radiation from telecom. apparatus is incomplete and inadequate. Until the situation becomes clearer the precautionary approach suggested in the Stewart report on mobile phones and health and recommended by the DETR in their guidance letter to planners dated 16/03/2001 should be followed by your Councils.
