

The AGM is a very important meeting in the Association's calendar. Please make a note of it and do your utmost to attend. It is a time when we can meet together as a community to discussed matters that concern us all, and time is given for individual members to raise matters that particularly affect them.

CHAIRMAN'S COMMENTS

In the "Mottingham News" it is usual for the Chairman's Comments to be a mixture of good news and bad news. However, for this issue, I am afraid that the only piece of good news that I can think of is that John Dartnell, one of our Section Leaders and a hard working member of the Executive Committee has made a successful recovery after a serious operation.

Two items on which I have to report in this issue relate to:

(a) the Borough Boundary changes which will come into effect on April 1st this year.

(b) the latest developments regarding the A20 gap closures.

As there is a lot to report on both these items, they are subjects of

separate articles in this issue.

You will be aware that Roger's hardware store in the village has closed. This is a great loss, as Michael and his father before him, have provided a valuable service to the residents of Mottingham for many years. At the request of many of you the Residents' Association wrote to Michael thanking him for his service to our community and wishing him well for the future. Once again, I would appeal to all residents of Mottingham to make as much use as possible of our village shops and services. It would be a tragedy if our village became just a row of empty shops.

We have also lost (temporarily I hope) the services of our Home Beat Police Officer P.C. Karen Hartley who is on sick leave. We wish her a speedy recovery and return to Mottingham. On the subject of policing you will no doubt be aware that, despite all our best efforts, Chislehurst Police Station is now closed from midnight until 6am. However, we have been assured that the Police response to any emergency calls will not be affected. Also, there is a telephone outside Chislehurst Police Station that is directly linked to the Police Authorities in Orpington.

I hope to see as many Mottingham residents as possible at our Annual General Meeting the Oddfellows' Hall in Beaconsfield Road on Wednesday

BOUNDARY CHANGES WITH EFFECT FROM APRIL 1ST 1994

BETWEEN BROMLEY BOROUGH AND LEWISHAM BOROUGH

The present boundary between Bromley Borough and Greenwich Borough runs between the Bistro and the old Barclays Bank, through the middle of the Library and on through the middle of the shops and premises on the north side of Mottingham Road. As this has caused many problems and anomalies; the boundary will be changed with effect from April 1st as follows: Along the north side of the Bistro and the Library and on behind the

shops and premises on the north side of Mottingham Road as far as Court Road where it will cut at an angle between the Carpet Shop and Edwards The Photographers to the middle of Mottingham Road then on eastwards along the middle of Mottingham Road. This will put all the premises from the bottom of West Park along to the Carpet Shop entirely into Bromley Borough and all premises from Edwards The Photographers entirely into Greenwich Borough

BETWEEN BROMLEY AND LEWISHAM BOROUGH

The present Borough Boundary runs along the ends of the gardens on the west side of Jevington Way and through the grounds of Grove Park Hospital. With effect from April 1st 1994 the boundary will be changed to run along the course of the River Quaggy, thus putting all of Jevington Way, Western Avenue and Grove Park Hospital from Bromley Borough into Lewisham Borough. As the area affected by the change has historically lain within the Parish of Mottingham, the residents have been represented by this Association. However, the members of the Executive Committee of the Association (all volunteers) already have two local authorities, two police divisions and two health authorities to monitor (Bromley and Greenwich), they do not have the resources to add the Lewisham local authorities to their workload. We therefore sent a circular letter to all the residents concerned, asking them if they wished to continue to be presented by this Association and if so would they volunteer to serve on the Executive Committee to liaise with the Lewisham local authorities. Of the 190 letters that were sent out we received only 17 replies. Only 14 of these wished to continue their membership and no one volunteered to serve on the Executive Committee. It is with much regret therefore, that the Executive Committee will at the Annual General Meeting be proposing an amendment to the Association's Constitution, defining the Association's area of responsibility as "all that part of the Parish of Mottingham that lies within the London boroughs of Bromley and Greenwich".

The only other boundary change brings all residents in Grove Park Road

into Bromley Borough.

CLOSURE OF THE GAPS IN THE CENTRAL RESERVATION OF THE A20

For some months now, Messrs Oscar Faber TPA, a firm of traffic management consultants employed by the Department of Transport, has been carrying out a study of the proposed Red Routes including the A2O. We have been in close liaison with Oscar Faber with the principal objectives of:

(a) Getting a roundabout constructed at the Dutch House, or at the very

least, providing for U-turns at that junction.

(b) Further improving traffic flows at the Court Road junction.

(c) Providing pedestrian crossings over the A2O, especially at the Green

Chain Walk (King John's Walk) and at the top of West Park.

As Oscar Faber seemed to be sympathetic to our requests, we were very disappointed when we visited a recent presentation of their suggested changes and found that none of our requests had been included. Oscar Faber advised us that the Department of Transport had intervened and precluded them from suggesting changes for the A2O as either the closed

gaps were "under investigation" or there were insufficient funds available. They advised us that the only course open to us was to write

to the Department of Transport.

I THEREFORE SUGGEST THAT WE FLOOD THE DEPARTMENT OF TRANSPORT WITH PAPER All Mottingham residents who have been inconvenienced by the gap closures and/or by the lack of pedestrian crossings over the A2O are urged to write NOW to:

Alternatively, if you contact me, Dave Edgar, at 32 West Park (Telephone 851 3788) I can let you have an official suggestion form of which I have a limited number.

We are not alone as we are in closed liaison with the Horn Park Action Group who also want a roundabout at the Dutch House and pedestrian crossings over the A20.

COUNCILLOR DEREK RICHARDS writes

What does a local Councillor get up to, people often ask. Well, in addition to attending quite a number of committee meetings at the Town Hall each month, especially those in which matters concerning his ward are up for discussion or decision. An experienced Councillor will walk around his ward vigilant for signs of change, disrepair or difficulty. He will also be pleased to follow up fellow residents' unresolved problems.

For example, in the extreme west of Tarn Ward Mottingham, between the Sidcup Road and Middle Park Avenue in some fifty yards of the Green Chain Walk, I observed.

1. The whole length of fencing of a house had blown down into a back

garden.

2. A London Borough of Greenwich notice board had been destroyed.

3. All light bulbs on the British Rail footbridge had been smashed or removed thus putting it out of use for any wise woman, elderly person or child wishing to use it.

4. Obscene graffiti had spoilt the London Electricity substation. I reported these matters for the attention of the Council's Leisure Services and Housing Departments, British Rail and London Electricity Board and arrangements have been made to deal with all these matters. At the eastern side of Mottingham on Fridays between 10.30am and 12.30pm free legal advice may be sought at Plumstead Law Centre (Outreach), The Mound, Coldhabour SE9. It is funded by the London Borough of Greenwich. One may just drop in or phone 855 9871 for a prior appointment. A Mottingham resident was allocated a renovation grant for the repair of his property. A requirement was to complete the work within twelve months. Sadly delay and dispute meant that the deadline would not be met, but I intervened with the Director of Housing and the deadline was extended.

A teenager normally insouciant, was most unhappy at her school. I visited the family to hear their viewpoint. I asked for meetings involving the Greenwich Education Officer and the school authorities and

now a much happier girl is working rather better in another school. An elderly lady who lives on the fringe of a park in Mottingham, was troubled after the park's closing time by people trespassing into her garden to enter the park. They aggravated the nuisance by breaking the fence, starting fires and using insulting words. I contacted the Directorate of Leisure Services who dealt with the matter and alerted the Park Police. These few instances might just give a flavour of a Councillor's service to his ward. Each incident is very important to one or more Mottingham residents. A more complete account could fill a book.

COUNCILLOR ERNY DYER writes:

One pressing problem facing local communities today is how to control or prevent crime. Recently there has been some success in reducing certain categories of crime but the trend in nearly all criminal activity is one of increase. The Council is seeking more co-operation between themselves the police and the public. To facilitate this there is to be a number of public meetings across the borough in the early months of the year. The intention being to gauge residents views of the relatively small increases in the council tax in order to fund specific security initiatives. The nearest such meeting to Mottingham is to be held on 21st March at Edgebury Primary School, Belmont Lane Chislehurst.

Whilst I favour more spending on street-level security, my four years experience as a councillor has taught me that there is considerable 'financial fat' that can be reduced to fund proposals to make our communities safer. I wonder whether the cost of the mayoralty, banquet, receptions, trips abroad etc., are absolutely necessary. I purposefully avoided all such 'freebies' and do not feel that this has adversely affected my role as a councillor. Indeed, I have more time available to attend to important public duties. So there is considerable potential within current budgets to divert to crime prevention without increasing the Council Tax.

We do need full co-operation between the Council, police and residents, but I think the only way we are going to reduce crime is to take a close look at our society; it is increasingly excluding a growing section of our young people many of whom are wasting their lives and potential on the dole. For years now Britain has experienced division in our communities as the over promotion of individualism and materialism, has had a detrimental effect on the welfare of our society. We might consider the purpose of economic growth, that 'idol' worshipped by most politicians. Is it to be simply to create more wealth for those fortunate to be in employment or should we not be considering other aspects of what makes for a healthy society, economic fairness, equality of opportunity and the like? Higher spending on security only addresses the symptoms of crime, not the underlying causes, and whilst necessary, I do not believe that this is enough.

In my last piece I requested information of local bird-life. The response was tremendous. Both Green and Great Spotted Woodpeckers nesting, owls, heron and nearly all the range of finches native to SE England and even a flock of Parakeets which has built up over the years from escaped domestic pets which have bred successfully have been

sighted. It is good to see such interest.

CHANGES TO BUS ROUTES

The 161 will in future link Woolwich and Chislehurst. The Section of the journey to Bromley North will be discontinued.

The 161A Woolwich to Chislehurst route which goes to Bromley North and Petts Wood at certain times will be discontinued altogether.

The lost buses will be replaced by a new minibus 162 service linking Beckenham Junction, Petts Wood Station and Chislehurst,

NEW ROUTE 424 to replace 124S and 160S.

This new route 424 will link Eltham Green, Grove Park, Mottingham, Eltham, Falconwood and Welling Corner with Crown Woods School, Avery Hill.

The Service will run at school starting and finishing times and WILL BE AVAILABLE TO ALL PASSENGERS. Bus passes, travel cards and all similar tickets will be accepted but the service will not run on Saturdays. Sundays or School and Public Holidays. M. DARTNELL

Many litter blackspots can be tackled without getting your hands dirty. Simply telling the land owner or site manager that you find the site unacceptably untidy or dirty may be enough to get action taken.

Bromley Council won the last 'Clean & Tidy' trophy for having the cleanest streets in the London area.

The Environment Promotions Co-ordinator of Bromley may be able to help with the loan of equipment such as litter pickers, a skip etc. All this is provided on a first come, first served basis.

If everyone decides to do something, no matter how small or big we will all enjoy the benefits of a cleaner environment.
