

PLANNING WARS

The object of the Mottingham Residents Association - inscribed in every membership card - is to safeguard the interests of the residents of Mottingham.

Never has that been more necessary than in the past year when the Association has had to contest numerous planning applications which could radically change - for the worse - the whole look and feel of the village. As an example of what could happen look at the two pictures below.

Picture 1 is the bungalow at 2A Court Farm Road - a perfectly good small family home built in the 1950s and situated near the Eltham College roundabout.



Picture 2 is a three storey block comprising 6 two-bedroom flats and 3 one-bedroom flats.



The link between the two may not be immediately obvious but it is a local man **Mr Jonathan Read** who has applied to demolish the bungalow and replace it with the block of flats. Mr Read lives in Mottingham Lane and needless to say his house is not overlooked by the same sort of three storey block of flats he is seeking to impose on people in Court Farm Road!

PLANNING WARS continued

The Court Farm Road application is just the latest in a long line of similar plans flooding into local councils at the moment. Needless to say the only person who thinks this particular plan is a good idea is Mr Read himself. Everyone else including neighbours, the Residents Association and Bromley council all think it's a dreadful idea and are opposing his application tooth and nail.

Bromley has already turned the plan down but Mr Read has now appealed to the Government Inspectors and at the time of this newsletter going to press, a decision is still awaited.

In the view of the Residents Association, if his appeal succeeds, it will be carte blanche for developers to seize on any site in the village and replace perfectly good houses with blocks of flats. The whole shape and character of village will be altered.

HOW WE KEEP AN EYE ON THINGS

Part of the money raised by your subscriptions goes on obtaining copies of all planning applications made to Bromley and Greenwich Councils. That is how we keep track of proposals like Court Farm Road above and also Philips and Dear (see later)

We receive lists from each council every month which we discuss and decide what action - if any - to take. Where we think there are important issues for the whole village, we make our views known to the council and also alert local residents.

It is important to stress that the Residents Association does not oppose planning applications for the sake of it – only where we think they will have a detrimental effect.

We therefore fought against a mobile phone mast by the War Memorial and anyone who has seen the mast at its eventual home outside the Dutch House pub will see we were right to do so.

Similarly when Gilberts garage closed down we opposed an application from Kwik-Fit but didn't oppose the application from Warrs the Harley Davidson people who are there now. Apart from the occasional loud roar from over-sized middle aged men on over-sized motorbikes, it is a much better proposition for the village than queues of cars getting their rusty exhausts replaced on a Sunday morning.

The key to successfully challenging bad planning applications is for local residents to write in or e-mail their local council. The more individuals who write and e-mail, the more likely the local council are to take notice.

This was demonstrated yet again recently with the application to turn Phillips and Dear into a late night take-away which was soundly defeated after dozens of letters, e-mails and two petitions.

KIMMERIDGE STAYS OUT OF BOUNDS TO TROUBLEMAKERS



Police are to seek an extension of the dispersal order which has been in force in the Kimmeridge area since June and has proved a big success.

The order covers an area bounded by Grove Park Road, Mottingham Road and Elmstead Lane and allows police to move on groups of people or individuals who are causing trouble.

Ironically it has proved most popular with local youngsters on the estate because it enables police to target gangs from outside the area who come in looking for trouble.

SAFER NEIGHBOURHOOD PANEL SPLITS

The Mottingham and Chislehurst Safer Neighbourhood panel is to split into two separate bodies. After holding joint monthly meetings for the past year, Chislehurst members felt their interests would be best served by having their own meetings from now on. The next meeting of the Mottingham panel will be on January 23 at Castlecombe Youth Club in Castlecombe Road at 7 PM.

Mottingham is now policed by two safer neighbourhood teams —one based in Chislehurst provided by Bromley police and the other based in Well Hall Road provided by Greenwich police—see contact details on back page.

XMAS LIGHTS

Our thanks again to Eltham College who are funding the Christmas lights in Mottingham this year. There will also be a Christmas tree in front of the Methodist church which is decorated by children from Dorset Road Infant school

REMEMBRANCE SUNDAY

PHILLIPS AND DEAR



The Association recently won a major victory against a plan to turn the former Philips and Dear electrical shop into a late night take-away.

We have commented in the past on the fact that Mottingham seems to have more offlicences and take-aways than anywhere else in South London At the last count there were 11 premises where you can buy alcohol or food till late at night— all in the space of 100 yards between the BP garage by the War Memorial and the Spar supermarket on the corner of Court Road.

In their wake comes a raft of problems from under-age drinking and gangs of youths to noise, smells and litter – all of which have combined in recent years to make Mottingham village an unpleasant place to be especially at night and weekends.

It wasn't surprising therefore that the application to turn Phillips and Dear's shop into yet another late-night takeaway open till 11 pm proved to be the proverbial straw that broke the camel's back and there was a furious reaction from local residents.

Greenwich Council was bombarded with 57 letters and e-mails of opposition and a petition containing 30 names. As a result, the initial planning hearing in September was postponed and eventually took place on November 8 th at the Lionel Road Community Centre on Westhorne Avenue. Feelings were still running high and a large number of local residents turned out on the night and also presented another petition – this time containing 80 signatures.

The Chairman of the Residents Association and the Membership Secretary Mrs Mackway-Jones made speeches opposing the application as did several residents. The only speech in favour of the plan came from the agent acting from the applicant who wouldn't reveal who his client was. There had been rumours it was Dominos Pizzas or even McDonalds but although challenged directly by a member of the audience, he flatly refused to reveal their identity.

When it came to the turn of the planning committee to have their say, every councillor who spoke - regardless of their political party - supported the residents and the application was unanimously voted down.

VOLUNTEERS WANTED

The Residents Association desperately needs volunteers to act as road stewards to distribute our newsletters and collect subs.

JIM DUNCAN

Jim Duncan who was for some years the local beat bobby in Mottingham has retired. An old style,no-nonsense policeman he patrolled Mottingham for five years between 1998 and 2003. For a time he was based on the Kimmeridge estate where crime fell dramatically and he was given the nickname of "Sheriff of Mottingham" by local youngsters.

He was also famous for once ending up in his patrol car in the duck pond at Chislehurst. Anyone who saw the Metro bobbing up and down gently in the water with the blue light still flashing will never forget the sight. "Diving " without due care and attention was one of the kinder comments made at the time!

In recognition of his service to Mottingham and the other communities he has served during his career, Jim has been nominated by the Metropolitan Police for a Lifetime Achievement Award.

UNDER AGE DRINKING

Police have appealed to adults not to buy alcohol for under age youngsters who hang around outside off-licences and supermarkets. It's one of the most common tricks employed by youngsters to get their hands on alcohol and whilst most adults refuse their requests to buy drink for them, others aren't so fussy.

In a recent case on the Kimmeridge estate a 13 year old girl was found by police in a drunken stupor and had to be taken to hospital. It transpired she had asked a man to buy a bottle of vodka for her which he had done. He had then insisted she follow him down an alley behind the shops before he would hand over the drink.

The girl was lucky because on this occasion the man handed over the bottle and did nothing else but the police say she was potentially in danger and the consequences could easily have been appalling.
